Location

The subject development is located between Sylvester Street and Mary Street, on the southern edge of the city centre. The site is situated in the Cultural Industries Quarter on the southern edge of Sheffield City Centre, close to the inner ring road.

The location is within easy walking distance of Sheffield Rail Station and Bus Interchange. Sheffield Hallam University's main campus is located close by to the north of the site, whilst the prime shopping areas of The Moor and all the services and facilities of the city centre are also close by.

The M1 Motorway is also easily accessible via Sheffield Parkway connecting the city with J33 to the East.

The subject properties comprises a ground floor commercial units, forming part of the high quality 'PLATFORM_' Private Accommodation development.

The Sylvester House unit benefits from a prominent road position as well as having fully glazed frontage. It is currently in a 'shell condition' with capped off mains electricity, water and drainage, ready for any tenants fit out.

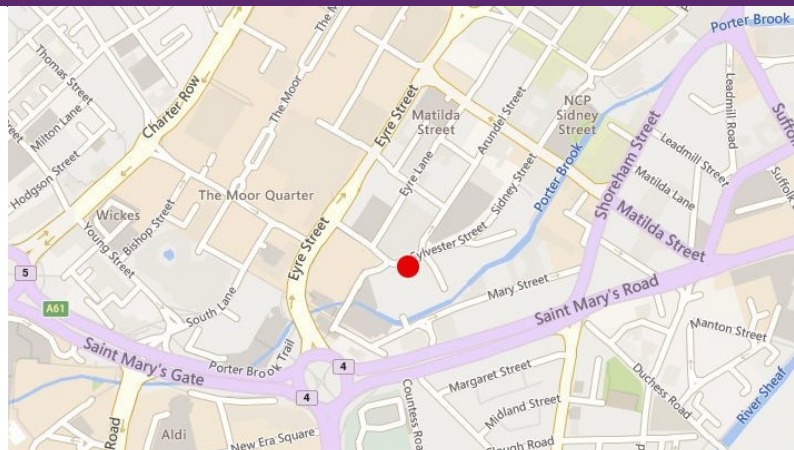
