The property is located in Rotherham, South Yorkshire approximately 5 miles north east of Sheffield and has an urban population of 257,800. Description

The premises comprise a modern warehouse/industrial unit with integral office space. The property consists of steel portal frame construction, with brick elevations to approx. 2m and profile metal cladding elevations above. The roof is also profile metal cladding with approx. 10% roof lights.

The property has a rollers shutter door, from the large, shared yard area. Internally the unit has offices at the ground floor. The premises benefit from 3 phase electricity. The unit benefits from a 447sq ft mezzanine.


