#### Location

The unit is located upon Longwall Avenue forming part of the Queens Drive Industrial Area on the South West side of Nottingham. The position is very popular given the ease of access to both the City's Inner and Outer Ring Road, providing onward connections to J24 and J25 of the M1 Motorway. The area has attracted key occupiers including Travis Perkins, Wickes, Howdens and Toolstation amongst many others. The location is very well connected to public transport routes with buses and the Nottingham Express Transit (NET) system serving the location. The estate is also linked to the City's cycle-route network.



The unit is a semi-detached end of terrace property, of steel portal framed construction with an attractive façade, featuring glazing within a mix of brickwork and cladding. The configuration provides a main warehouse, with two-storey office and welfare element. Key features include:

- Concrete loading apron
- LED warehouse lighting
- Warehouse heating
- Forecourt parking
