

The subject site is located on the corner of Milton Street and Fitzwilliam Street within the Devonshire Quarter of Sheffield City Centre. Fitzwilliam Street links Division Street and West Street to the North and Moore Street to the South.

Sheffield's Inner Ring Road is located within 500m to the South West, which in turn links to Sheffield Main Line Train Station and the A57 (Sheffield Parkway) leading out to J33 of the M1.
