Location

The property is situated on Shearwood Road, which is a nothrough street accessed off Glossop Road, adjacent to the junction with Clarkson Street. Glossop Road leads East towards the inner ring-road, situated within 350m and then immediately continues into the city centre.

Shearwood Road is within close proximity to Sheffield Children's Hospital, Sheffield Hallamshire Hospital (and associated Hospitals) and the University of Sheffield. As such, the majority of the surrounding properties are a mix of uses linked to these establishments/institutions, as well as private commercial occupiers and various residential occupiers.

Description

The property main comprises a detached, Victorian villa, originally constructed as two dwelling houses, but more recently used for academic and office purposes. There is accommodation over 3 upper floors, with the addition of substantial cellar area that may also be brought into usable accommodation.

The property also benefits from two purpose built, detached modular building facilities, which are situated either side at the front of the property, offering substantial additional floor space.


