Location

The property is located fronting Herries Road South adjacent to Penistone Road (A61) in Sheffield. The property is a short distance from the Hillsborough Football Ground and established Hillsborough Trade Point. The estate is approximately 2 miles north of Sheffield City Centre and close to Penistone Road which is a main arterial route with around 50,000 traffic movements each day.

Description

The property comprises a large industrial/manufacturing which is undergoing a full refurbishment. The refurbishment is to include new roof lights and overclad roof, full redecoration, new concrete warehouse floor, new external cladding and new LED lighting. The property is arranged across two large open plan bays with a single roller shutter door access. The building is built of brick and block work construction, surmounted by a metal trussed roof. The property has a small area of first floor office space.

Externally, the property has a secure loading yard area.


