The end of terrace unit is a single bay of steel portal frame construction, with predominantly brick and blockwork elevations. The roof is pitched and made up of an insulated profile system. The property has been subject to substantial refurbishment and benefits from the following features:

- Ground level roller shutter loading door, electrically operated
- Two-storey office and welfare accommodation
