The subject property is located within Cartledge House Business Centre, immediately accessed off Dirty Lane within Great Hucklow. Great Hucklow is a village within the Peak District that can provide access to Manchester or Sheffield via the A623 or A6. It is located just 15 minutes drive from Bakewell.

Description

The subject property comprises of 2 storage/warehouse spaces located on a modern farm development. Externally, the units benefit from steel profiled cladding with brick and block elevations. The units share a concrete yard/loading area and benefit from communal car parking for each unit.


