Location

Description

The property comprises 2xSemi-detached offices with accommodation over ground and first floor, each with their own entrance and stair/lift core.

The property is let to a single occupier who has created internal access between the units allowing occupation of the whole as a single demise.

The current Tenant is undertaking refurbishment works to the property, however, the office currently benefits from the following specification:

DDA compliant access

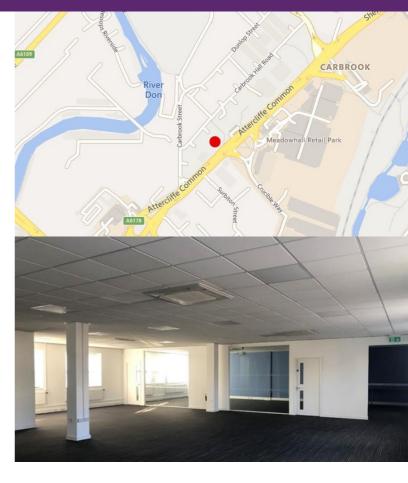
Accommodation
