Location

Broad Lane Court is located in Sheffield City Centre, just minutes from the Sheffield Supertram, NHS hospitals and major road links. The property is situated adjacent to University of Sheffield's city campus. It benefits from prominent frontage onto Broad Lane which leads directly to Sheffield Ring Road (A61) and other major road networks.

This location is also close to popular amenities such as numerous cafes, shops, and restaurants, as well as being minutes walk from West Street which boasts many bars and lively nightlife scene. Its mix of residential, commercial, and leisure amenities makes it a thriving location for development.

Description

Broad Lane Court is a purpose built student accommodation complex surrounding a private, central courtyard.

The property was purpose built in 1993 and comprises 214 bedrooms and ancillary accommodation in 4/5/6 bedroom cluster flat with shared bathroom facilities. Due to the gradient of the land, the buildings stagger from 2 storey to 4 storeys in height. There is also a detached building accommodating a central laundrette and secure internal cycle parking area.

This is a rare opportunity to acquire a major redevelopment/refurbishment opportunity in the city centre, within very close proximity to The University of Sheffield's main campus.


