Description

The units are situated adjacent to a central estate road, and are of steel portal frame construction with part brick and part steel clad elevations, set beneath a pitched roof which benefits from insulated roof panels. Internally, the units comprise open span warehouse with minimum eaves of 4.6m and benefitting from ancillary office and toilet accommodation. There is a shared yard with 24-hour access.

Units 14 & 16 can be taken separately or as a whole.

Location

The units are situated on Stadium Way within Barbot Hall Industrial Estate, which is well placed in Rotherham to the North of the town Centre. The properties are accessed from Rotherham Road (A633), one of the main arterial routes through Rotherham and within close proximity to Junction 34 of the M1, which is just 3 miles from the site.


