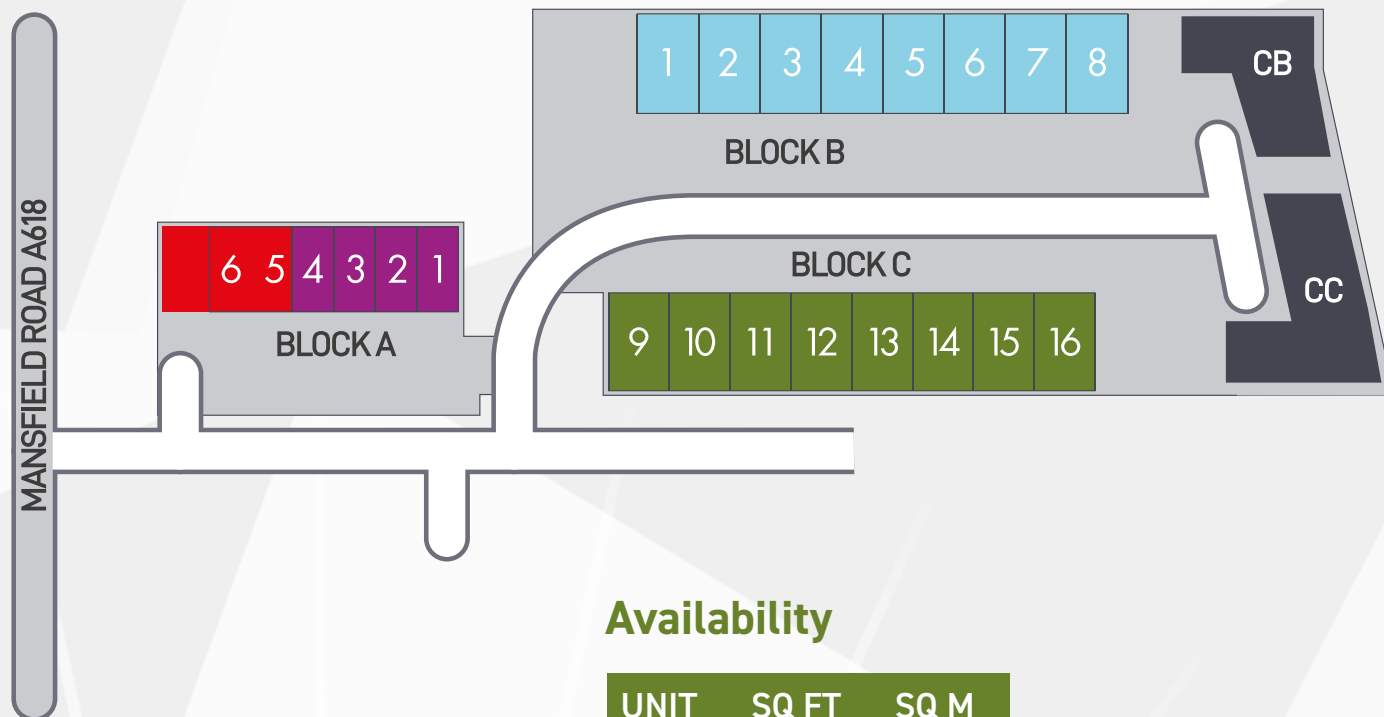
Conveniently located near the entrance to Gulliver's Valley Theme Park Resort, the estate has attracted both national and local occupiers.

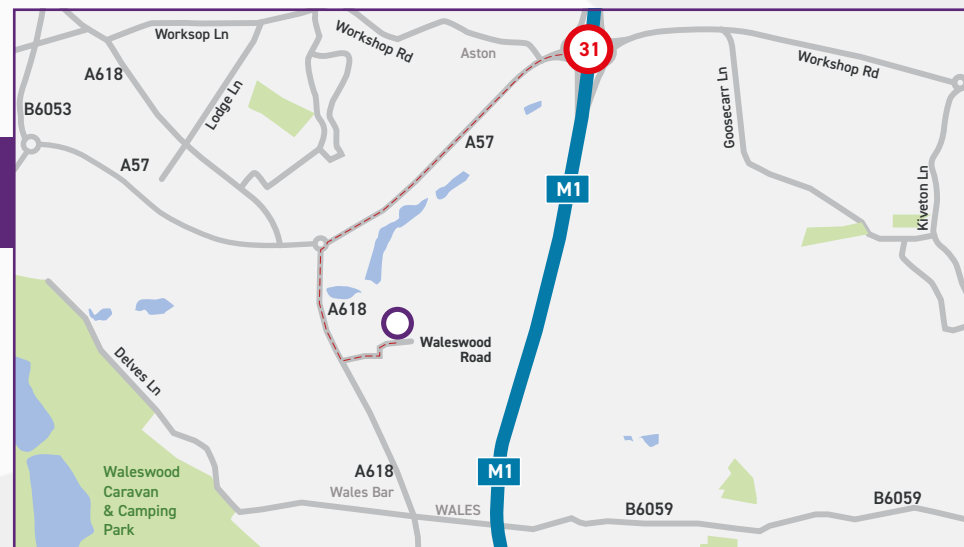
