Location

The property is situated on Marlborough Street, close to its junction with Northumberland Road in the Crookesmoor areas of Sheffield. Northumberland Road leads immediately onto the A57 (Whitham Road) which in turn leads either into the city centre to the East or out to the affluent residential suburbs of Sheffield to the West.

This location is a very popular residential location with a mix of occupants including students, young professionals, families and the elderly. This location is also adjacent to the University of Sheffield and within close proximity to the Royal Hallamshire Hospital and the other associated medical buildings.

The inner ring road for Sheffield City Centre is 0.75 miles to the East. Sheffield Main Line Train Station is also within 1.5 miles to the East.

Description

Marlborough House comprises a detached Victorian Villa, originally constructed in 1880 as a single dwelling. It has been most recently used as a HQ office facility, with a two-storey flat roof extension to the Southern elevation of the site which was added in 1958. The property features a yard area suitable for parking to the front of the property overlooking Northumberland Road.

The interior of the property remains in its original configurations, with accommodation split across 3 storeys and featuring a basement storage area.


