Palmerston Road is located between Northumberland Road and Claremont Place, both of which link Glossop Road to the south and Whitham Road (A57) to the north.

The Royal Hallamshire Hospital is within very close proximity, being situated at the road on Claremont Place. Sheffield Children's Hospital is also within close proximity, located in the opposite direct, being situated off Northumberland Road. Furthermore, The University of Sheffield's main student union is situated within 250m to the east.

## Description

This property comprises a detached late 19th Century, Victorian Villa, with accommodation over 4 levels and a large garden area to the rear.

Although vacant, the property was last used as Office.


