Location

The property is situated off the A6005, the main road running through Beeston and Attenborough, approximately 5 miles south-west of Nottingham and 11 miles east of Derby. Junction 25 of the M1 motorway is around 3.5 miles (9 minute drive).

The property is in close proximity to Chilwell Retail Park, which boasts a range retails shops, McDonalds and Costa. Key commercial occupiers in the wider area include DSM, Murphy & Son Ltd and Canon.

Description

The property is of concrete and brickwork construction with a flat roof that has been overclad. UPVC windows have been installed throughout.

The premises are arranged over two floors, comprising workshop, ancillary, WCs and storage areas on the ground floor. The first floor provides a mix of office accommodation to the front, together with ancillary stores, a meeting room, and WCs. The property is set back from the road and is accessed via a shared drive.


