This unit is an end of terrace, steel portal frame building with brick and blockwork elevations surmounted by a profile cladding system. The roof is pitched, and features translucent panels to some 20% cover. Internally the premises feature a 2-storey office/ancillary block and externally dedicated forecourt parking and loading is provided.


