Description

The properties are arranged within a detached terrace of steel portal frame units that have been overclad and set beneath a pitched roof as part of recent refurbishment works.

The units are available either individually or combined, providing flexibility to accommodate a range of business requirements. Each unit benefits from level access loading, LED lighting, a kitchenette, WCs, a painted concrete floor, 3 - phase power and separate service connections.

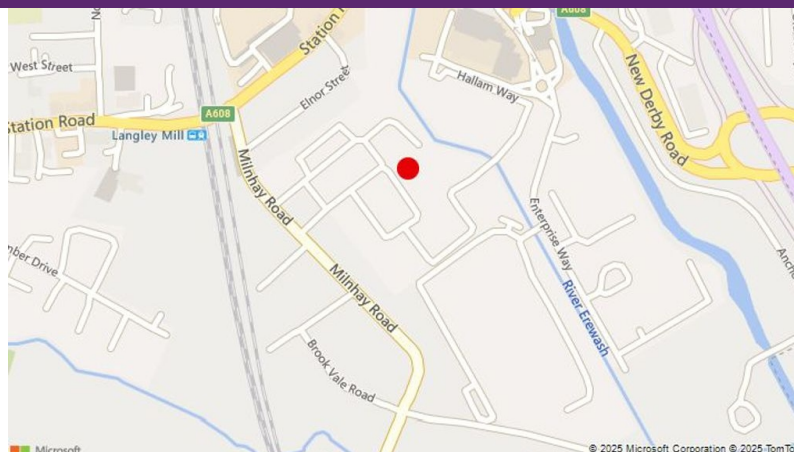
