Location

Beeley Wood Industrial Estate is located a short distance away from the main arterial route of the A61 Penistone Road. The site is approximately 2 miles North West of Sheffield City Centre and is located within a popular and established commercial location.

Penistone Road is the main arterial route linking the City to the North via the A61 which in turn provides access to J36 of the M1 motorway.

Description

The property comprises an industrial use canopy with associated concrete yard, situated within the established Beeley Wood Industrial Estate in Sheffield.

The canopy provides a covered area of approximately 6,685 sq ft, suitable for a range of storage, distribution or light industrial uses, benefiting from a total site area of approximately 10,230 sq ft. The yard is fully concrete surfaced, offering practical external space for loading, storage or vehicle manoeuvring.

The unit benefits from metered power and water supplies, with CCTV already installed, enhancing operational security. The property is available immediately and is offered at a rent of £2,000 + VAT per calendar month.

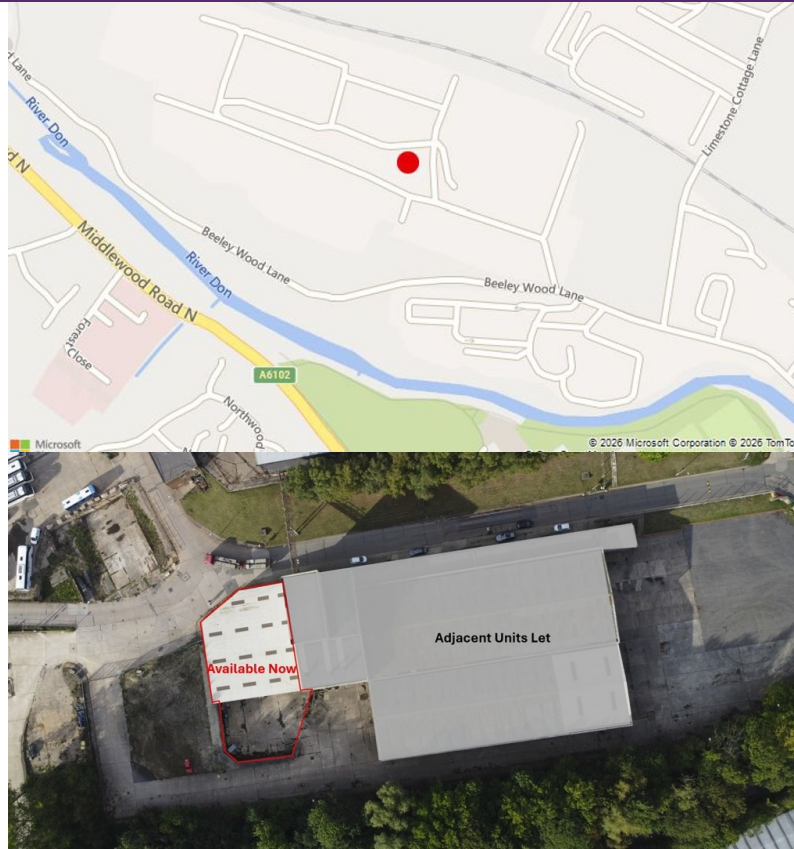
