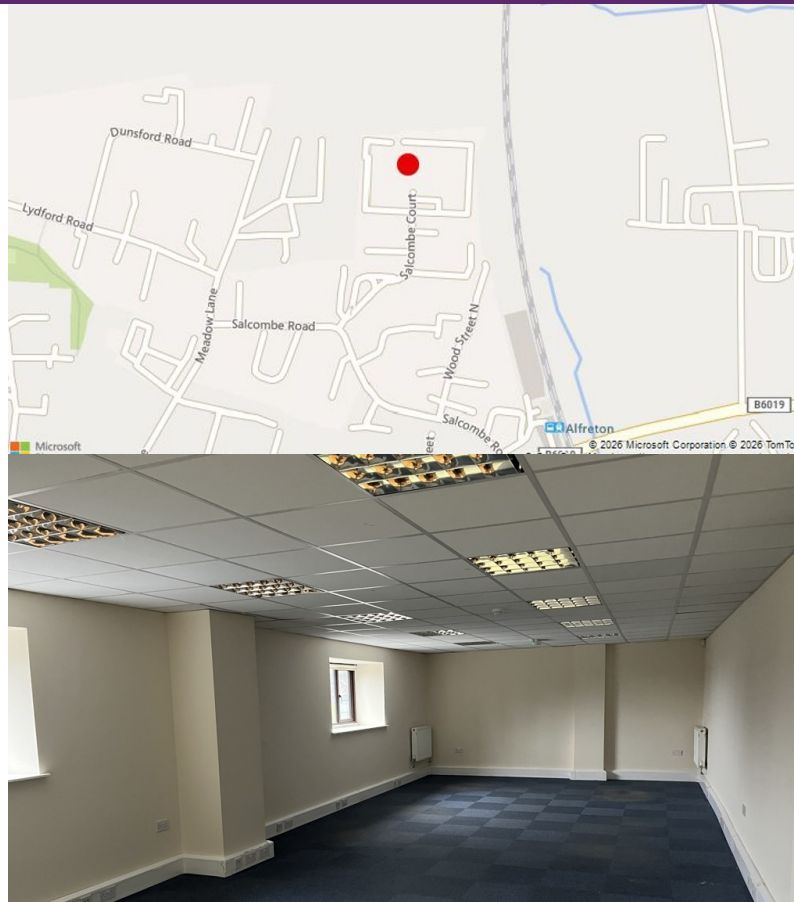
The property is offered for sale at a price of £1.3 million. Consideration may be given to a new lease on full repairing and insuring terms on a rent to be agreed.
