Location

The property forms part of Troon Industrial Park, located in north east Leicester, approximately three miles (a 14 minute drive) from Leicester city centre. The A607 is situated around 1.5 miles away, providing access to the A46, and Junction 22 of the M1 motorway is approximately 14 miles away (around a 27 minute drive).

The area benefits from strong bus route connections and is well served by local amenities, including nearby cafés and Vantage Park, which features a Costa Coffee and an Aldi.

Description

The property comprises a secure, modern, high quality detached warehouse unit of steel portal frame construction, incorporating brick and blockwork to the lower elevations with steel profile cladding to the eaves. The building is surmounted by a pitched roof incorporating translucent light panels. Externally, the site benefits from a self contained yard.


