Avro Park is a scheme of brand new unit adjacent to Doncaster Sheffield Robin Hood Airport. Situated approximately 6 miles of Doncaster City Centre. The M18 motorway is approximately 1.5 miles away accessed via the A6182.

### Description

The new unit provides a modern warehouse space and includes office/toilet accommodation as follows:

- Reception area with stairs, lift and disabled toilet
- Toilets accessible to the warehouse
- Kitchen/tea point
- Stairs and lift
- Toilets
- Open plan office area at first floor

The unit has a concrete service yard and a separate tarmac car park area with disabled parking.

The building is a duo pitched steel frame construction, with a mixture of full height factory finished steel cladding, using a mix of micro-rib and trapezoidal profiles. The roof is to be a factory finished metal cladding system, complete with angled fascia's and soffits.

Services include a metered 3 phase electricity mains electricity and water.


