## 13,625 Sq Ft (1,265.76 Sq M)

### Location

The subject property is located on Jessell Street within the established industrial Lower Don Valley area of Sheffield. This area is well known for its concentration of industrial, warehouse, and distribution uses, making it a popular and practical location for a range of commercial occupiers.

The site benefits from strong road connectivity, with easy access to the A6109 and A631, both of which link the unit to Junction 34 of the M1 motorway approximately 1.5 miles to the east.

The surrounding area is home to a variety of established industrial and trade occupiers.

### Description

The property comprises a detached industrial unit incorporating two high bay warehouses together with a two-storey office block.

The warehouses are of steel portal frame and steel truss construction with a combination of brick/block and profile clad elevations beneath single pitched roofs, together with solid concrete floors.

Each warehouse benefits from roller shutter door access and is equipped with a 3-tonne overhead crane, providing functionality for a range of industrial and manufacturing uses.

The office accommodation is arranged over two storeys and is of traditional brick construction. Internally, the space is configured to provide cellular offices along with associated welfare facilities. A trade counter is also in place, making the unit well suited to trade counter or distribution occupiers.

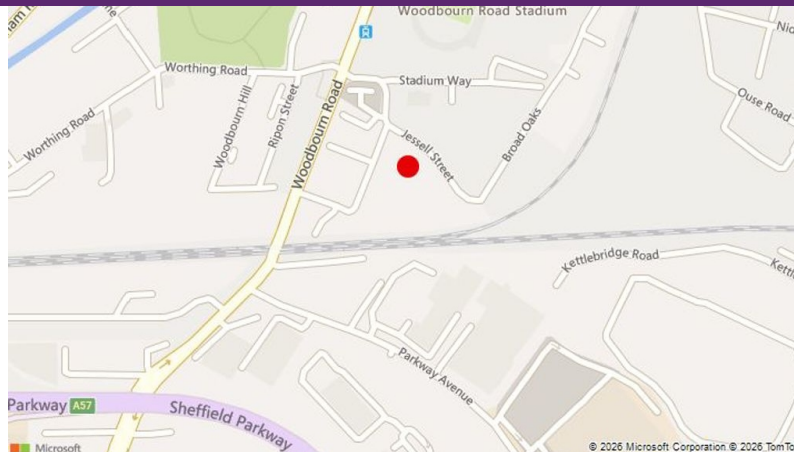
