Location

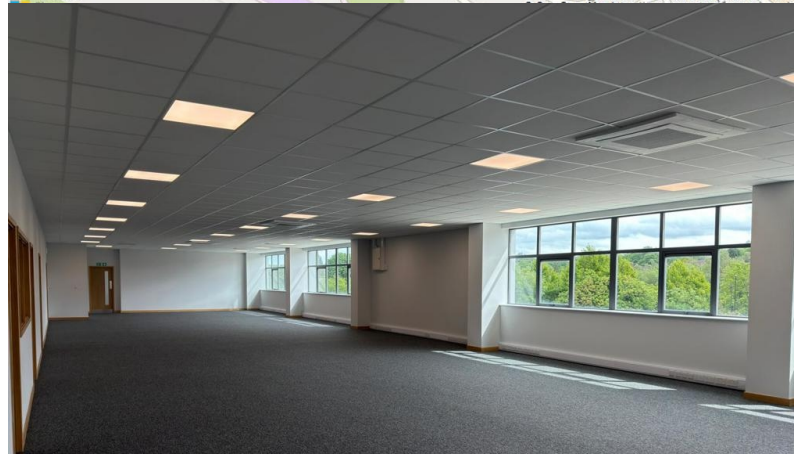
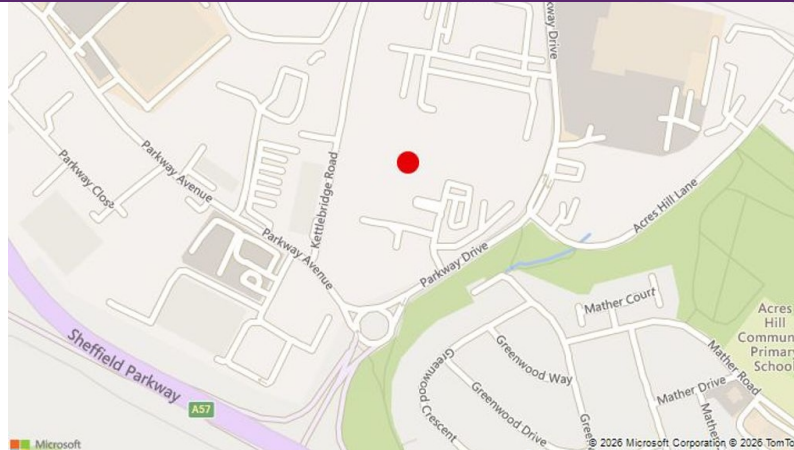
