Location

Unit 3 Greasborough Street is positioned immediately adjacent to the busy College Street Roundabout (A629). The property lies within a well-established trade counter area, just a short walk from Rotherham Town Centre and approximately one mile from Parkgate Retail World. The unit benefits from strong transport links, with Rotherham Central railway station and the bus interchange nearby. Road connectivity is equally strong, with Junction 33 of the M1 motorway within minutes. The surrounding area supports a mix of commercial, retail, and light industrial uses.

Description

The property is a brick-built unit with a single-pitched roof arranged over two floors. A roller shutter door provides convenient access, ideal for loading and unloading. The ground floor offers space suitable for storage, workshop, or trade counter use, with the first floor providing additional accommodation for offices, display, and other purposes. Externally, the property benefits from use of a communal car park located to the rear, offering additional parking for staff and visitors.

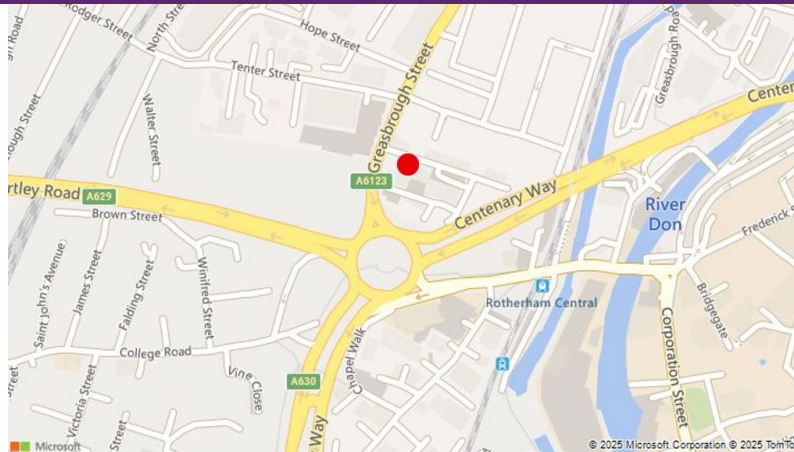
