Location

Unit 4 is located on the Stonegravels Industrial Estate, just off Meltham Lane in Chesterfield. The property benefits from strong prominence, fronting the A61 Rother Way, a major arterial route providing excellent visibility and high passing traffic. Chesterfield town centre lies approximately 1 mile to the south-west, while Junction 29 of the M1 motorway is easily accessible via the A617. The surrounding area is a well-known commercial location, home to a variety of trade counter, industrial, and distribution occupiers.

Description

The unit comprises a prominent trade counter / industrial unit of steel portal frame construction, featuring brick and block elevations surmounted by an unequal pitched profile clad roof. The front of the unit is accessed via a pedestrian door into a trade counter, with a roller shutter accessed unit to the rear. Externally, the unit benefits from a secure rear yard, together with an additional customer / staff car park to the front. The prominent position offer excellent visibility, making it particularly well suited to occupiers seeking a functional unit with strong trade counter potential.

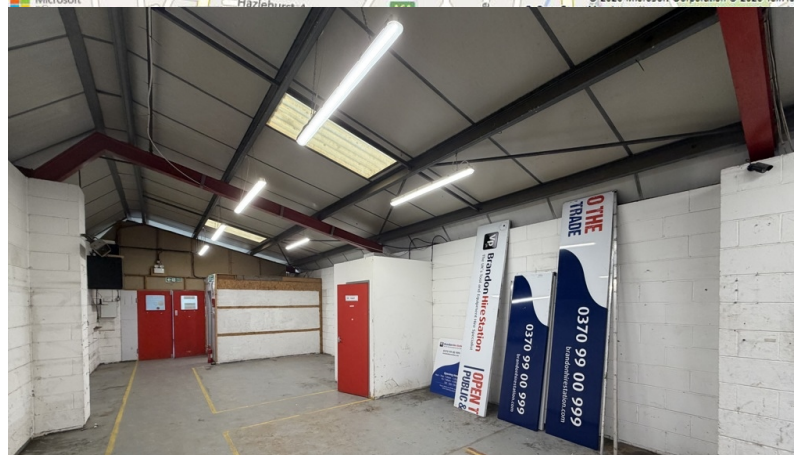
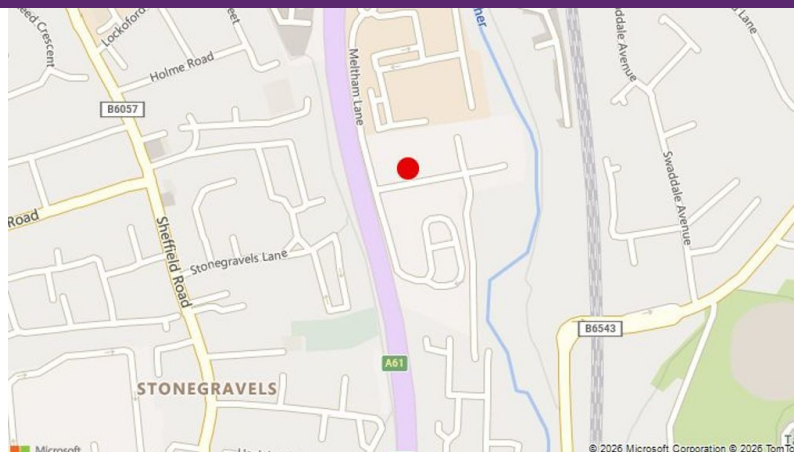
